PURCHASE TERMS

The following are Proliphix terms and conditions of sale and license for hardware, software and subscription products, ("Products").

GOVERNING TERMS All sales of Proliphix products are subject solely to these terms and those on the face of a valid Proliphix quotation. No other terms and conditions in addition to, or in conflict with these terms not separately and specifically executed by both parties as an amendment to these terms shall apply.

ORDERS Orders must be in the form of a valid, binding Purchase Order issued by Customer and must reference a Proliphix estimate or existing purchase agreement, state the Proliphix part numbers, descriptions and quantities of products. Proliphix may reject any non-conforming Purchase Order.

PRICES All prices are in United States Dollars.

TAXES AND FEES Prices do not include any export fees, duties, GST, sales, use, excise, ad valorem, property withholding from source income or other taxes of any nature, or other taxes or fees applicable to the sale, use, license, or delivery of the Products, all of which are the responsibility of Customer.

DELIVERY Equipment sold and software licensed are delivered F.O.B. Proliphix' Westford, MA. Proliphix will, unless otherwise requested by the customer, select the carrier and will separately invoice shipping and insurance.

LICENSES, PERMITS AND EXPORT CONTROL Customer will comply fully with the export control laws and regulations of the United States Government and will indemnify Proliphix for any claims or penalties incurred as a result of any violation of applicable United States law or regulations.

LIMITED WARRANTY AND DISCLAIMER OF WARRANTY

Proliphix Products, are warranted to the end-user to be free from defects in materials and workmanship and to substantially conform to Proliphix's specifications in effect as of the date of shipment under normal use for a period of three years from the date of shipment. Proliphix sole obligation under this warranty for non-conformances occurring and reported to Proliphix within the warranty period, is to provide a like-new replacement for a device, or a correction/work around for software or subscription service by download or other appropriate method. Proliphix does not warrant that use Products will be uninterrupted or error free. In the event of a warranty failure end-user customers must call Proliphix at (978) 692-3375, secure a return authorization and ship the failed device, with all original, unaltered markings and labels, pre-paid to Proliphix. The foregoing hardware, software and services warranties do not extend to defects or nonconformities resulting from unauthorized disassembly, misuse, improper installation or use, abuse, acts of God, modifications, or unauthorized maintenance. This limited warranty does not cover the repair of broken, scratched or damaged plastic or other cosmetic non-conformities.

THE FOREGOING WARRANTIES REPRESENT PROLIPHIX'S SOLE OBLIGATION AND CUSTOMER'S SOLE REMEDY FOR NON-CONFORMANCES. THE FOREGOING WARRANTIES ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. Your warranty rights under State law may differ and certain of these disclaimers may not apply.

SOFTWARE LICENSE AGREEMENT Use of the Software provided embedded in and as a part of Proliphix Products is subject to the terms of the Proliphix Software License Agreement provided with the Product and also available at Proliphix.com/softwarelicense, and the terms herein. Connection to and use of Proliphix hosted management services is subject to these terms and those of the Proliphix Software License or Subscription Agreement.

FORCE MAJEURE Proliphix is not liable for loss or damage due to failure or delay arising out of any cause beyond its reasonable control.

PAYMENT Orders are subject to Proliphix's credit approval. Proliphix may charge the Customer 1.5% interest per month or part on any past due amounts. Customer shall reimburse Proliphix for all reasonable costs and expenses of collection including attorney's fees.

ASSIGNMENT Neither party may assign its rights or obligations hereunder without the other party's consent, which consent shall not be unreasonably withheld.

APPLICABLE LAW These terms shall be governed by the laws of the Commonwealth of Massachusetts excluding its conflicts of laws rules. The United Nations Convention for the Sale of Goods shall not apply to any transactions hereunder.

CANCELLATION/RESCHEDULE Orders accepted by Proliphix are non-cancelable, non-returnable and non-refundable. Orders may be rescheduled a single time, by written notice no later than 30 days prior to a scheduled ship date, for up to forty-five (45) days without charge.

PATENT INFRINGEMENT Proliphix agrees, at its expense, to defend Customer in any suit, claim or proceeding brought against Customer alleging that the Proliphix products directly infringe any U.S. Letters Patent or U.S. copyright, provided Proliphix is promptly notified of any actual or threatened claim, is given all reasonable assistance required, and is given sole control over the defense or settlement of the claim, at Proliphix' expense. Proliphix agrees to pay any final judgment rendered in such suit. Should the use of any equipment or software be enjoined, or in the event that Proliphix desires to minimize its liability hereunder, Proliphix may fulfill its obligations hereunder by, either substituting fully equivalent non-infringing items, or modifying the infringing item so that it no longer infringes, or by obtaining for Customer, at the expense of Proliphix, the right to continue use of such item. If in Proliphix' sole judgment, none of the foregoing is feasible, Proliphix may take back such item and refund to Customer its then depreciated purchase price. The foregoing states the entire liability of Proliphix for patent or copyright infringement or for any breach of warranty of non-infringement, express or implied. The foregoing indemnity shall not apply to any equipment made to the specification or design of Customer or to claims based upon the combination of any Proliphix Products with products or software supplied by Customer or others.

LIMITATION OF LIABILITY PROLIPHIX SHALL NOT BE LIABLE FOR BUSINESS INTERRUPTION, LOSS OF DATA, PROFITS OR REVENUE, OR SPECIAL, IN-DIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY NATURE AND FROM ANY CAUSE WHETHER BASED IN CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHER LEGAL THEORY, EVEN IF PROLIPHIX HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT WILL PROLIPHIX BE LIABLE FOR DAMAGES OF ANY KIND IN EXCESS OF THE PRICE PAID FOR THE PRODUCTS PROVIDED HEREUNDER.

VALIDITY Should any provision of these terms be found illegal or unenforceable in any respect, such illegality or unenforceability shall not affect the validity any other provision of this terms.

ARBITRATION Any dispute arising in respect of these terms shall be referred to arbitration conducted in Boston, MA under the rules of the American Arbitration Association. The award rendered in such arbitration will be final and binding and may be enforced in any court of competent jurisdiction. Each party shall bear its own costs incurred in the arbitration action. Notwithstanding the provisions of this section, any party may seek injunctive relief in any court of competent jurisdiction in order to protect its proprietary and confidential information and to enforce or obtain compliance with the scope of rights and licenses granted under these terms without first submitting such claim to arbitration.
